The paper should be limited to no more than twenty (20) multiple-spaced pages (1.2) including the references, figures, diagrams, etc. Papers exceeding 20 pages are automatically rejected by the Editor. The margins of the paper are set to: Top (2)/ bottom (2)/ Right (1.5)/ Left (1,5).

2. SECTION TEMPLATE OF MANUSCRIPTS

2.1 Sub-Section (Lowercase letters)

The text of the Journal may be in Arabic, English, or French. This document is designed to serve as a template of your paper.

Please note that the first paragraph of every section and subsection is left flush and all other paragraphs are indented by .2" as shown in this section.

To ensure that all papers provide a consistent appearance and uniformity, you should follow the below specifications.

- Font is Cambria for the whole document;
- One (1) 16-point blank line should be before the title.
- The title should be in 16-point **bold** type.
- The sub-title should be in 14-point **bold** type
- Two (2) 12-point blank lines should appear next.
- A title section is in **Bold** and UPPERCASE LETTERS

- All type from this point should be in 12 point.
- Figure: All figures should be good quality and numbered with Arabic numerals (1, 2, etc.). Figures must be embedded into the text and not supplied separately.
- Tables: Data charts which are typically black and white and declared within the text.

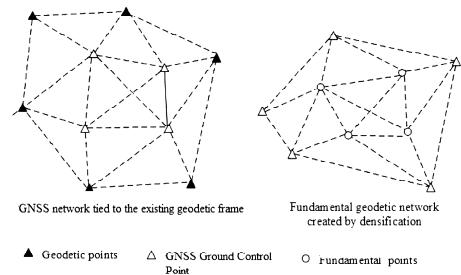


Fig. 1. Example of a figure (300 dpi of resolution).

2.2 Submission process

- h. In the next page, click « choose file »,
- i. Select your templated file in Word format,
- j. click « upload » and « save and continue »

AuthorName, F1.; Author, F2.; & Author, F3 (YYYY). Title of the paper. See below.

Journal paper:

Author / Authors (according to the previous specifications). The title: sub-title. Journal name, Volume N°(Issue N°), pp.xx-yy.

Edited book:

AuthorName, F. (YYYY). Title of the book. City/Country, Edition N°. Editor. Pp.xx-yy

Chapter in an edited book:

Author / authorsName (YYYY). Title of the manuscript. **In Book** (Edition N°), Title of the book: Sub-title (pp. xx-yy). City/country, Publisher.

Published proceedings:
